## **Big Changes Coming for Massachusetts Superior Court and District Court Civil Cases**

Significant backlogs and bottlenecks at the state court level, resulting in civil cases that can drag on for three or more years, have caused the Massachusetts Supreme Judicial Court to increase the procedural amounts requirement for cases filed in state District Courts and the Boston Municipal Court from \$25,000 to \$50,000. The expectation is that lawyers and litigants will use the District Courts to resolve "smaller" disputes, freeing up the Superior Court dockets for civil damages cases seeking more than \$50,000. While this presents opportunities for citizens and businesses frustrated by the slow pace and expense of Superior Court litigation, it presents pitfalls and strategic considerations for lawyers and their clients alike.

Starting this January, if the claimed damages in a new lawsuit exceed the revised District and Boston Municipal Court amounts, or do not meet the new Superior Court minimum procedural amount, those claims can be dismissed.


### Middlesex County Bar Association Outstanding Service Award

### at Massachusetts Lawyers Weekly Crisis Management Conference




