

<u>First Circuit Court of Appeals Enforces Non-</u> <u>Solicitation Agreement Where Client Makes</u> <u>First Contact in Soliciting Former Employee</u>

Employers of salespeople often have the good sense to have those employees sign non-solicitation agreements before they start work-after all, a company's worst nightmare is having a star salesperson skip town like the pied piper, with a line of the company's clients marching behind him.

But is it solicitation when a client is the one to reach out to the ex-employee? A new ruling from the First Circuit Court of

inability to satisfy project specifications, and sought to award the contract to another tank installer. At the court's hearing, we successfully argued that the awarding authority's specifications were proprietary and, therefore, violated public bidding laws. As a result, the awarding authority had no other option but to cancel its contract and re-bid the project; this time, in accordance with public bidding laws.

Adam Ponte prevailed in a Superior Court trial this month when a jury returned a defense verdict for our client, an industry-leading national restaurant chain. The jury rejected plaintiff's claim that the floor tile was defective and posed a safety hazard. We presented an expert engineering witness who tested the co-efficient of friction of the floor tile and testified that it exceeded industry standard for slip resistance. We also rebutted the Plaintiff's damages by showing that her alleged back injury was caused by previous, unrelated accidents.

recently achieved a victory for our client, a company which constructed and maintained a confined disposal facility ("CDF") pursuant to a license issued by the Massachusetts Department of Environmental Protection. Our client constructed the CDF for the purpose of providing for the permanent containment and isolation of contaminated sediments dredged from the Island End River in Everett. Our client was under a continuing obligation to monitor and maintain the CDF in good repair. Attorneys Michael Sams and Amanda Cox brought suit on behalf of our client against a trespasser who was illegally mooring large vessels to the side of the CDF. Due to the damage the vessels were

Appeals suggests, to the relief of employers, that the answer may be "yes." Although that Federal Court decision is not binding on Massachusetts State Courts, it is strong ammunition for a wronged employer, and may be enough keep those clients from leaving.

causing as well as the potential for further and serious damage to the structure, Attorneys Sams and Cox obtained a Temporary Restraining Order which required the trespasser to remove his vessels from the CDF. Although it required the filing of a Complaint of Civil Contempt, the trespasser removed his vessels from the CDF before they could cause a release of hazardous materials from within the structure into the Island End River.
